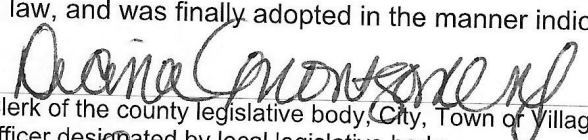

A LOCAL LAW AMENDING CHAPTER 255 (ZONING) OF THE VILLAGE OF SPRING VALLEY CODE TO
REQUIRE STRUCTURES ABOVE THREE FOUR FLOORS TO GO BEFORE THE VILLAGE BOARD

§ 255-27.1 Special permits for structures above three floors.

A.

In all zones, where it is not permitted as of right, a special permit is required if the developer seeks to construct any structure greater than three stories.

B.

In its determination whether to grant a developer the right to construct a four story structure, whether in zones where it is permitted as of right or only by special permit, the Village Board shall consider whether the construction of such a structure is likely to cause excess density in the area, create a need for additional parking, whether the property can otherwise safely accommodate the number of bedrooms proposed and other relevant matters; and all other requirements set forth in §255-25, and §255-27 listed above.

C.

Nothing set forth hereinabove relieves a developer from compliance with the Zoning Code requirements regarding maximum units per acre and floor area ratio.
