ORDINANCE 2025-12
AN ORDINANCE AMENDING PART II SECTION 167-25 OF THE BOROUGH CODE**

Borough of Longport Code Provision Chapter 167-25 is hereby amended as follows:

§ 167-25 Signs.

A. General provisions. No signs may be placed on or attached to a building or erected independently for any purpose other than to advertise a permitted business or use conducted on the same premises. No billboards shall be erected or replaced which are not in accordance with the standards established in this chapter. Unless otherwise specified in this chapter, the erection of any sign shall require a construction permit. No sign of any type shall be permitted to obstruct driving vision, traffic signals, traffic directional and identification signs, other places of business or other signs or windows of the building on which they are located. No sign shall be attached to trees, fences, posts, stumps, utility poles or other signs, but shall be freestanding or attached to buildings in an approved manner. [The Borough of Longport and the Borough Free Public Library are hereby exempt from the provision of this Ordinance and may display any sign, banner, advertisement, flyer, etc. as approved by the Mayor.]
