#### Uses Permitted by Zoning District

Land uses permitted under this chapter are listed alphabetically on the following pages.

Each use is a permitted or conditional use in the zoning districts listed and in all higher-numbered zoning districts with the same letter classification.

For example, a use listed as a permitted use in RS-1 is also a permitted use in RS-2 and RS-3. A use listed as a conditional use in C-2 is also a conditional use in C-3, C-4 and C-5. Where no district is listed for a land use, that use is not permitted in any district.

For detailed requirements, please consult the district regulations in the Zoning Code itself.
