**AN ORDINANCE AMENDING PART 12, CHAPTER 5, ARTICLE K  
TRANSPORTATION IMPACT FEE, SECTION 12-616 BY ADDING  
COMMERCIAL COLLECTOR STREETS AS ALLOWABLE EXPENDITURE OF  
TRANSPORTATION IMPACT FEE FUNDS; PROVIDING FOR SEVERABILITY;  
PROVIDING FOR REPEALER.**

Be it ordained by the Council of the City of Moore, in the State of Oklahoma, as follows:

**SECTION 1:**        **AMENDMENT** “Sec 12-616 Use Of Funds” of the Moore Land Development Code is hereby *amended* as follows:

AMENDMENT

Sec 12-616 Use Of Funds

Funds collected from transportation impact fees shall be used only to pay for capital improvements to the transportation system within the corporate limits of the city, as recommended in the transportation system plan or the most current capital improvements plan as follows:

- A. Capital Improvements to the arterial roadway system;
- B. Capital Improvements to the commercial collector roadway system; and
- C. Matching funds to obtain state or federal surface transportation program funds.

**SECTION 2:**        **REPEALER CLAUSE** All ordinances or resolutions or parts thereof, which are in conflict herewith, are hereby repealed.






