

ORDINANCE NO. 2025-13

AN ORDINANCE TO AMEND CHAPTER 165, ARTICLE II, SECTION 165-13, PROHIBITED USES, OF THE CODE OF THE TOWN OF MYERSVILLE, TO REMOVE THE PROHIBITION OF BILLBOARDS AND TO PROHIBIT THE KEEPING OF SWINE WITHIN THE TOWN OF MYERSVILLE ZONING ORDINANCE.

SECTION I. BE IT ENACTED AND ORDAINED, by the Mayor and Council of the Town of Myersville that Chapter 165 “Zoning”, Article II, Section 165-13 of the Code of the Town of Myersville be, and hereby is, amended as hereinafter provided. New language is designated by being **IN BOLD CAPITAL LETTERS**, and deletions are designated by being ~~{in brackets and stricken through}~~.

Chapter 165 – Zoning

Article II – General Provisions

§ 165-13 **Prohibited Uses.**

- A. ~~{Billboards are prohibited in all districts.}~~
- B. – H. {Unchanged}
- I. ~~{(Reserved)}~~ **SWINE. KEEPING, HARBORING, BREEDING OR POSSESSION OF ALL SWINE IS PROHIBITED IN ALL ZONING DISTRICTS EXCEPT FOR THE FOLLOWING:**
 - (1) **A LAWFUL AND ACCREDITED ZOOLOGICAL PARK WHICH COMPLIES WITH THIS CHAPTER AND ALL OTHER LOCAL, STATE AND FEDERAL LAWS.**
 - (2) **A LAWFUL AND ACCREDITED WILDLIFE SANCTUARY OR NATURE PRESERVE WHICH COMPLIES WITH THIS CHAPTER AND ALL OTHER LOCAL, STATE AND FEDERAL LAWS.**
 - (3) **A LAWFUL AND ACCREDITED SCIENTIFIC, MEDICAL OR EDUCATIONAL RESEARCH FACILITY WHICH COMPLIES WITH THIS CHAPTER AND ALL OTHER LOCAL, STATE AND FEDERAL LAWS.**
 - (4) **EXCEPTIONS. THE REQUIREMENTS OF § 165-13I SHALL NOT APPLY TO:**
 - (a) **LICENSED HUMANE SOCIETIES.**
 - (b) **ANIMAL CONTROL OFFICERS.**

(c) LICENSED VETERINARY HOSPITALS OR CLINICS.
