

**ORDINANCE NO. 518**  
**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LINDSAY**  
**ADDING SECTION 18.01.090 TO TITLE 18 (ZONING) RELATING TO**  
**STATE AND FEDERAL LEGALITY OF THE USE OF LAND WITHIN CITY**  
**LIMITS.**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LINDSAY FOLLOWS, TO WIT:

SECTION 1. Section 18.01.090 is herewith added to Title 18, Chapter 18.01 of the Lindsay Municipal code to read as follows:

18.01.090      Legal Use of Land. No use of land, under this Title, shall be permitted within the City Limits if such use shall be in violation of any local, state, or federal laws.

SECTION 2. All other provisions of Chapter 18.01 of Title 18 shall remain in full force and effect.

SECTION 3. The foregoing Ordinance shall take effect thirty (30) days after passage. Prior to the expiration of twenty (20) days from the final adoption of this Ordinance shall be published once in a local paper of general circulation and delivered within Lindsay, together with the names of the members of the City Council voting for and against this matter.

The foregoing ordinance, read by title only with waiving of the reading in full, was introduced at a regularly scheduled meeting on the 13th day December, 2005.


