However, illumination of theater marquees may be increased upon approval by the Board of Appeals; in no instance shall the total illuminated sign area be more than 30 square feet. 4. Location of signs: (a) A sign attached to a building shall not project more than 3 feet from the building wall or 1 foot from the roof of an arcade; but no sign, except a sign painted on an awning shall project more than 1 foot over a street. However, a sign erected as a part of a theater marquee may extend to the curbline. (b) Maximum height of any sign shall not be more than 30 feet above ground level. (c) Near R District boundaries, see additional use regulations and § 4.32(E). (d) Except as modified by No. 4(c) above, sign not attached to a building shall be set back at least 25 feet from the front lot line; except that any accessory sign to a building in existence on the effective date of this code need not be set back from the front lot line a greater distance than the setback of such building. 5. (c) Not more than 5 persons shall be engaged in such production or servicing. (d) Only electrically driven machinery shall be used. 4.
