

ORDINANCE NO. 599

AN ORDINANCE AMENDING SECTIONS XXII, XXIV, AND XXVI OF ORDINANCE NO. 559; AMENDMENTS OF SECTION XXII CHANGES THE FEE SCHEDULE; SECTION XXIV MAKES VIOLATION OF THE ORDINANCE A MIS-DEMEANOR AND PROVIDES FOR THE PUNISHMENT THEREFOR; SECTION XXVI PROVIDES THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That Section XXII of Ordinance NO. 559 is amended to read as follows, to-wit:

"SECTION XXII, FEES: From and after February 1, 1979, there is hereby assessed for each occupied residence and/or occupied residential premises within the City of Rexburg upon which refuse accumulates, the following monthly charges, to-wit:

Since family dwelling units, including housetrailer and/or mobile homes (whether within or without trailer courts), duplex units, triplex units, apartment house units, and rooming house units-----\$3.00 plus \$2.00 for each additional unit

All other residential units-----\$3.00

From and after February 1, 1979, there is hereby assessed for non-residential premises within the City of Rexburg upon which refuse accumulates, the following monthly charges, to-wit:

Churches-----\$5.00

All motels, cabin camps, offices, occupied business, commercial or other premises are hereby assessed upon the basis of the number of garbage cans and approved containers used and the number of weekly pickup services furnished, all in conformity with the following schedule, to-wit:

Bulk refuse pickup ----- \$16.00 per hour

All garbage and/or refuse requiring more than six cans shall be placed in cubic yard containers. Any garbage exceeding six cans will not be picked up."


SECTION II: That section XXIV of Ordinance No. 559 is amended to read as follows, to-wit:

"SECTION XXIV, VIOLATION A MISDEMEANOR AND PENALTY: Any person, firm or corporation who fails, neglects or refuses to comply with the provisions of this ordinance shall be deemed to be in violation thereof and guilty of a misdemeanor and upon conviction thereof shall be subject to a fine not to exceed \$300.00 for any such offense and such person may be confined in jail for a period of not more than thirty (30) days. Either or both such fine and imprisonment may be imposed and in addition thereto, any person so convicted shall pay such costs as the court may assess. Each day's failure to comply with any such provision shall constitute a separate violation."

SECTION III: That Section XXVI of Ordinance No. 559 is amended to read as follows, to-wit:

"SECTION XXVI, EFFECTIVE DATE: This ordinance shall become effective February 1, 1979.
