

AN ORDINANCE AMENDING SECTIONS 405.108 OF THE MUNICIPAL CODE OF THE CITY OF DESLOGE, MISSOURI, ADDING A SUBSECTION AND TABLE FOR DESIGNATED HANDICAP PARKING SPOTS

WHEREAS, the Board of Aldermen of the City of Desloge, Missouri, desires to add a subsection to the City Code to designate specific parking spots for handicap parking.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF DESLOGE, MISSOURI, AS FOLLOWS:

Section 1. Section 405.108 of the Municipal Code of the City of Desloge, Missouri, is hereby amended to add the following new subsection "C". The remainder of 405.108 shall remain unchanged.

C. The City of Desloge designates the following as Handicap Parking Spaces:

Section 2. Codification.

It is the intention of the Board of Aldermen of the City of Desloge, Missouri, and it is hereby provided, that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Desloge, Missouri; that the sections and/or table numbers of this ordinance may be renumbered or re-lettered to accomplish such intention; and the words "ordinance" may be changed to "section," "article" or other appropriate designation.

Section 3. Severability.

If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 4. Effective Date.

This ordinance shall be in full force and effect from and after its passage and approval.
