- E. Recommending approval or denial of subdivision applications to the Town council as provided in Utah Code 17-27, as amended;
- F. Advising the Town Council on such matters as the Town Council directs;
- G. Hearing or deciding any matters that the Town Council designates, including recommendations to approve or deny conditional use permits;
- H. Exercising any other powers delegated to it by the Town Council; and
- I. Exercising any other powers that are necessary to enable it to perform its functions.

**SECTION 9: REPEALER CLAUSE** All ordinances or resolutions or parts thereof, which are in conflict herewith, are hereby repealed.

**SECTION 10: SEVERABILITY CLAUSE** Should any part or provision of this Ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the Ordinances a whole or any part thereof other than the part so declared to be unconstitutional or invalid.


**SECTION 11: EFFECTIVE DATE** This Ordinance shall be in full force and effect from February 15, 2023.


